Bid sent by FAX or e-mail will not be considered. If the renderer withdraws the tender before the said period or issue of letter of acceptance whichever is earlier or makes modifications in the terms & Condition of the tender which are not acceptable to the competent authority then the competent authority will be at liberty to forfeit 50% of the said earnest money.

- 7. <u>Earnest Money Deposit</u>.
